### **Members Report**

#### NATURE, OBJECTIVES AND STRATEGIES:

The members present their report and the audited Financial Statements for the year ended 31 July 2020.

#### Legal status

The Corporation was established under The Further and Higher Education Act 1992 for the purpose of conducting the affairs of Joseph Chamberlain Sixth Form College. The College is an exempt charity for the purposes of Part 3 of the Charities Act 2011.

#### Mission

The College reviewed the mission of the College during 2016/17 and in January 2017 adopted a revised purpose statement as follows:

"To provide an exceptional learning experience for all of our students, raising their aspirations and improving their achievements so that they can enjoy a level of success in later life that realises their highest ambitions".

#### **Public Benefit**

The College is an exempt charity under Part 3 of the Charities Act 2011 and following the Machinery of Government changes in 2016 is regulated by the Secretary of State for Education for Sixth Form Colleges. The members of the Governing Body, who are trustees of the charity, are disclosed on page 16.

In setting and reviewing the College's strategic objectives, the Governing Body has had due regard for the Charity Commission's guidance on public benefit and particularly upon its supplementary guidance on the advancement of education. The guidance sets out the requirement that all organisations wishing to be recognised as charities must demonstrate, explicitly, that their aims are for the public benefit.

In delivering its mission, the College provides the following identifiable public benefits through the advancement of education:

- · High quality teaching
- Tackling social exclusion
- Excellent record of facilitating progression to higher education, further training and employment
- Excellent pastoral support for students
- Work related placements and links with employers
- Links with Local Enterprise Partnerships (LEP's)

#### Implementation of strategic plan

The College chooses to update the strategic plan on a rolling basis and the latest update covering the period 2016 to 2019 was issued in January 2017. The College was in the process of finalising a new Strategic Plan until COVID19 forced the College to lockdown and the ability to undertake workshops for obtaining the views of all stakeholders. It has been decided that the existing Plan will be extended until 2021 with the same objectives.

The College's current strategic ambitions are:

- 1. The Academic Achievements and success of Our Students-to be highly ambitious for all of our students and prioritise their success so that they achieve the highest standards academically, making significant progress throughout their time with us:
  - 1a To exceed the national averages for achievement rates across all ages, levels and provision types
  - 1b To ensure that all of our students make outstanding levels of progress, based on their starting points on entry to the College
  - 1c To ensure that levels of student attendance, punctuality, behaviour, progression and satisfaction are excellent for all students and indicative of a first-class institution

The College is on target to achieve all of the strategic objectives by 31 December 2020. The Principals Report to each Corporation meeting addresses progress against all of the individual objectives.

#### Financial objectives

The College's financial objectives are:

- to achieve a minimum 5% EBITDA of income operating surplus in 2019/20 and 2020/21 in order to support the implementation of the Building Condition Survey and to provide sufficient resources to tackle COVID for both staff and students
- to provide sufficient financial resources to maintain OfSTED outstanding grade achieved in November 2017 by achieving a positive operating cash-flow
- to ensure that the College controlled Sports Centre achieves a minimum break-even outturn in 2019/20 and thereafter
- to investigate options for securing additional teaching and social space as the College nears maximum capacity and ensure that the College has sufficient cash reserves to implement any proposals
- to ensure that sufficient teaching support resources are available to assist the teaching staff in delivering successful student outcomes whilst ensuring that staff costs do not exceed 70% of income excluding Franchise income

A series of performance indicators have been agreed to monitor the successful implementation of the policies and to maintain the College's financial health grade as outstanding.

Under the ESFA approach to assessing the financial health of Colleges, the College is currently graded as outstanding.

With the exception of the Current Ratio all of the above targets were achieved. The Current Ratio was lower due to the various unbudgeted refurbishments undertaken using the ESFA historical Devolved Maintenance Grants.

The College is committed to observing the importance of the measures and indicators and is monitoring the financial indicators through the completion of the annual Integrated College Financial Model for the ESFA. The current official financial rating of Outstanding is considered an acceptable outcome.

#### FINANCIAL POSITION

#### Financial results

The College and its subsidiary companies generated an operating surplus in the year of £1,056,000 (2018/19: £785,000). The surplus includes FRS 102 pension costs of £336,000 (2018/19:£398,000) arising from the incorporation of the FRS 102 pension liability. The remaining costs relating to the pension liability are recognised in Other Comprehensive Income.

The College and its subsidiary companies have income and expenditure reserves of £14,736,000 after providing for the pension liability and £22,960,000 before the provision (2018/19: £18,342,000 and £21,573,000 respectively).

#### Financial results (continued)

The College wishes to maintain cash balances in order to create a contingency fund to support new building works and the need to implement the recommendations from the recently completed Building Condition Survey.

Tangible fixed asset additions for the Group during the year amounted to £1,921,000 (2018/19: £324,000).

The College has significant reliance on the education sector funding bodies for its principal funding source, largely from recurrent grants. In 2019/20, the funding bodies provided 94.5% (2018/19: 91.2%) of the College's total group income.

The College has two subsidiary companies, Joseph Chamberlain (Trading) Limited, and The College for International Citizenship CIC.

The principal activity of Joseph Chamberlain (Trading) Limited is the community use of the Sports Centre.

On 16<sup>th</sup> May 2011, Joseph Chamberlain (Trading) Limited acquired the whole of the issued share capital of The College for International Citizenship, a public interest company formed to acquire the assets of an organisation that was originally set up in 2004. The principal aim of the company is to carry on activities which benefit the community and in particular, without limitation, to provide educational courses in international citizenship to students aged 16 or over from the local, national and international community.

In the year ended 31 July 2020, Joseph Chamberlain (Trading) Limited generated an operating deficit of £8,505 (2018/19: £8,250 surplus).

In the year ended 31 July 2019, the College for International Citizenship CIC generated a small deficit of £21 (2018/19: £235 surplus).

#### Treasury policies and objectives

Treasury management is the management of the College's cash flows, its banking, money market and capital market transactions; the effective control of the risks associated with those activities; and the pursuit of optimum performance consistent with those risks.

The College has a separate treasury management and investment policy in place.

Short term borrowing for temporary revenue purposes is authorised by the Chief Accounting Officer. Such arrangements are restricted by limits in the Financial Memorandum previously agreed with the LSC and subsequently transferred to the ESFA. All other borrowing requires the authorisation of the Corporation and shall comply with the requirements of the current ESFA Condition of Funding Agreement.

#### Cash flows

The Consolidated Cash Flow Statement on page 28 shows an overall out-flow of £182,000 (2018/19: £4,371,000 in-flow). Both of the above figures are impacted by the College's transfers to and from an investment fund. Overall bank and investment balances increased by £398,000 (2018/19: £1,338,000). The out-flow was in respect of the planned capital expenditure.

#### Liquidity

During the year, the College repaid the final bank loan balance of £125,000 (2018/19: scheduled repayment of £250,000). The loan was originally taken out to help finance the construction of the new campus and sports hall.

The size of the College's total borrowing and its approach to interest rates has been calculated to ensure a reasonable cushion between the total cost of servicing debt and operating cash flow. During the year this margin was comfortably exceeded.

#### Reserves Policy

The College has no formal Reserves Policy but recognises the importance of reserves in the financial stability of any organisation, and ensures that there are adequate reserves to support the College's core activities. As at the Balance Sheet date the Income & Expenditure Reserve stands at £14,736,000 (2018/19: £18,342,000). It is the Corporation's intention to increase reserves over the life of the strategic plan through the generation of annual operating surpluses. The actual reduction in the Reserves figure is impacted by the inclusion of the LGPS deficit which increased by £4,993,000 (2018/19: £640,000) which is a long term liability, is not due to be settled anytime soon and the deficit may well reduce in the coming years. There is no real cash impact of this liability.

# CURRENT AND FUTURE DEVELOPMENT AND PERFORMANCE

#### Student numbers

In 2019/20 the College delivered ESFA funding of £11,833,000 which was £366,000 above the allocation figure of £11,467,000. The 16-18 actual learner numbers were 109 higher than the revised in-year adjusted figure and this increase contributed to the significant over delivery position. In terms of the West Midlands Combined Authority (WMCA) activity the College delivered an outturn figure of £1,872,000 excluding Discretionary Learner Support of £72,000 compared to the £2,158,000 total allocation. However due to COVID19 impact the College only delivered c90% of the WMCA allocation. At this stage we do not anticipate any clawback of funds.

The College enrolments, including sub-contract recruited students, for 2019/20 can be summarised as follows:

#### Student achievements

The A level achievement rate in 2019/20 was high again at 98.6% (2018/19-98.7%), with a high grade performance of 55% (2018/19-49%). Level 3 BTEC results showed a high pass rate of 98% (2018/19-98%), with high grade performance of 87% (2018/19-87%).

Measures of value added, assessed by the ALPS methodology, for A level students ensured that the College retained its place in the top 25% of the country. For BTEC students value added progress was equally strong.

Curriculum developments

The College continues to have a high reputation for serving students from a wide range of backgrounds, ages and abilities. It is continually reviewing its course offer to ensure that it matches the needs of its students. The introduction in 2019/20 of AS equivalent courses in Criminology has proven to be a highly successful development and the number of students progressing to the second year have been high. The College is also considering new AS levels in applied Human Biology and Psychology from September 2021.

The College received approval for delivering HE programmes in 2018. Recruitment in September 2019 was again low and the College made the decision to withdraw from this sector from September 2020.

The College also obtained approval from Birmingham City University to enrol students onto a Diploma in Education & Training programme from September 2018. This programme was successful in 2018/19 and 2019/20 and will be continuing for the foreseeable future.

The adult programme offer is also continually refined to meet funding guidance and more importantly the needs of the local communities. We are looking into developing more full cost programmes and working collaboratively with other adult providers in the City. Our excellent partnership arrangement with the Birmingham Education Ethnic Advisory Service continues to serve local people in other areas of the City.

The College also undertakes collaborative work with schools where appropriate. Opportunities are given to students from feeder schools to undertake work placements on the College site. The college also hosts the Work Related Learning Team which provides work placement opportunities to the main site students. Partnerships with a number of employers have been developed this year.

Strong links and partnerships with the Universities of Cambridge, Warwick, Coventry, Aston and Birmingham City continue to benefit students when applying to these institutions. The College is also a "valued partner" of the University of Birmingham's A2B scheme. A large number of College students attend summer schools and visits to universities such as Birmingham, Cambridge and Oxford. Students also participate in maths challenges and master classes at both Aston and Birmingham University.

However, the impact of COVID has seen the College move to a blended learning model of teaching from September 2020 and whilst it has proved successful and welcome by staff and students any long term impacts have yet to be determined.

#### Payment performance

The Late Payment of Commercial Debts (Interest) Act 1998, which came into force on 1 November 1998, requires colleges, in the absence of agreement to the contrary, to make payments to suppliers within 30 days of either the provision of goods or services or the date on which the invoice was received. The target set by the Treasury for payment to suppliers within 30 days is 95 per cent. During the accounting period 1 August 2019 to 31 July 2020, the College paid 54.66% of supplier invoices representing 52.40% in value (2018/19-51.47% and 43.86%) of all its invoices within 30 days. Both figures are a significant improvement on 2018/19. This figure includes invoices where the College has negotiated extended payment terms. The College processes a fortnightly supplier BACS run to ensure prompt payment of approved supplier invoices.

The delayed payment of high cost franchise and exam invoices are contributory factors in the above statistics due to the additional signing off procedures for such transactions.

The College incurred no interest charges in respect of late payment for this period.

#### Post Balance Sheet events

The College completed the acquisition of the former Birmingham Car Auctions site as part of the strategical plan to increase available space for main campus developments. The purchase cost of c£1,500,000 including fees was completed using College cash reserves.

The other post Balance Sheet event is the continuing ever-changing impact arising from COVID and compliance with Government and Public Health England guidelines.

#### Trade union facility time

The Trade Union (Facility Time Publication Requirements) Regulations 2017 require the college to publish information on facility time arrangements for trade union officials at the college. The table below reflects the position for the year ended 31 March 2020 and this was uploaded onto the College website in line with the Regulations.

#### **Future developments**

The College is under demand led funding and hence the recurrent grant from the main funding bodies for 2020/21 has been confirmed at £13,063,000 from the ESFA and £2,074,000 from the WMCA. The 16-18 figure is c£1,596,000 higher than in 2019/20 due to changes in the national funding rate, higher student numbers and additional programme weightings. The adult funding allocation from the WMCA has not changed from 2019/20.

The College has completed phases 1 and 2 of the refurbishment plans and phase 3 is due to be completed in 2020/21. The College has also secured a CIF Grant of £2,100,000 towards the c£4,100,000 cost of constructing additional classrooms and this necessitated the purchase of the Car Auction site referred to above.

#### RESOURCES

The College has various resources that it can deploy in pursuit of its strategic objectives.

Tangible resources at £29.9 million include the main campus, sports centre and the Orchard House teaching block.

#### **Financial**

The College and its subsidiary companies have £14,736,000 of net assets (including £8,224,000 defined benefit pension liability). At 31 July 2020, the College and subsidiary companies had no borrowings and cash and short term deposits and investments of £12,104,000.

#### People

The College employs 232 people (expressed as full time equivalents), of whom 136 are front line teaching staff.

#### Reputation

The College has an excellent reputation locally and nationally. Maintaining a quality brand is essential for the College's on-going success at attracting students and developing future external relationships.

#### PRINCIPAL RISKS AND UNCERTAINTIES

The College has undertaken further work during the year to develop and embed the system of internal control, including financial, operational and risk management, which is designed to protect the College's assets and reputation.

Based on the strategic plan, the Senior Leadership Team undertakes a comprehensive review of the risks to which the College is exposed. They identify systems and procedures, including specific preventable actions, which should mitigate any potential impact on the College. The internal controls are then implemented and the subsequent year's appraisal will review their effectiveness and progress against risk mitigation actions. In addition to the annual review, the Senior Leadership Team will also consider any risks which may arise as a result of a new area of work being undertaken by the College.

A risk register is maintained at the College level, which is reviewed at least annually by the Audit Committee and more frequently where necessary. The risk register identifies the key risks, the likelihood of those risks occurring, their potential impact on the College and the actions being taken to reduce and mitigate the risks. Risks are prioritised using a consistent scoring system.

The College has also, in response to COVID, created a secondary Risk Register to ensure that all COVID risks are reduced and comply with Government and Public Health England guidelines.

#### Equal opportunities and employment of disabled persons

Joseph Chamberlain Sixth Form College is proud of its commitment to equalising opportunity for all who learn and work at the College. The College respects and values differences in race, gender, sexual orientation, physical ability, class and age. The College has in place policies to address these issues and has a coordinating Equality and Diversity Committee which has oversight of the implementation, monitoring and development of policy and reports to the Corporation. An annual report is prepared each year for consideration by the Corporation. The College continues to support and fund an Equality and Diversity Co-ordinator.

The College's Equal Opportunities Policy, including its Equalities Policies, is published on the College's intranet site.

The College considers all applications from disabled persons and offers an interview to all disabled people who meet the job and person specification for any post. Where existing employees become disabled, every effort is made to ensure that their employment at the College continues. An equalities action plan setting clear targets is published each year and the identified actions are monitored by the governing body. This complies with Equality legislation.

#### Disability statement

The College is committed to a policy of responding to the general needs of the community and the specific need of the individual. Disability or additional educational needs shall be defined as learning requirements that need support or provision additional to or different from that which is normally available. The College has published a policy statement in relation to students with learning difficulties or disability. The main provisions of this statement include:

- to ensure increased access to the College from all sections of the community, regular liaison with schools, community groups, careers and guidance services and agencies working with those with specific learning difficulties and / or disabilities (SLDD) will be promoted and supported.
- the College application procedure will offer applicants the opportunity to provide information and
  discuss any special learning difficulty or disability that affects them. However, the College recognises
  that not all students may be willing or able to do this and that it is the responsibility of the College to
  ensure that alternative procedures are in place to identify and assess potential learning difficulties
  and that other opportunities exist to enable students to disclose any SLDD.
- in the event of a place not being offered to a student with a learning difficulty or disability, a record will be kept of the reasons given. Where possible, alternative options and guidance will be given in liaison with Prospects and Social Services, etc.
- when a student who wishes to enrol at this College cannot be admitted because the College cannot
  meet her or his learning needs, this information will be put before the Corporation.
- advice will be available to students with disabilities or additional learning needs before, during and
  at the end of their course so that students can examine their individual needs within their progression
  route.

#### Approach to students with disabilities

As an important part of the College relocation project, a full access audit was undertaken and the facilities provided fully comply with all access legislation. Other appropriate measures are taken such as the use of specialist furniture and software.

The College has a Specific Learning Difficulty and Disability Coordinator, who provides information, advice and guidance and support to students who apply or are at the College. She interviews all prospective students

with declared difficulties or disabilities and prepares a support plan for them should they enrol at the College. Use is made of specialist sign language and care staff.

In recent years, the College has significantly expanded the number of support assistants it employs to ensure its duties are met. It now employs 15 support assistants. The Disability Equality Scheme and associated action plan are published on the web site.

Whilst parent governors are nominated to the Corporation for a period of four years, if their child/children leave the College before the end of the four-year period, their term of office ends at the next full Corporation meeting following the election of their successor.

The staff elects staff governors for a period of four years, but their term of office ends if they leave the employment of the College before the end of the four-year period.

The following person has been co-opted to a subcommittee of the Corporation to provide additional expertise:

It is the Corporation's responsibility to bring independent judgement to bear on issues of strategy, performance, resources and standards of conduct.

The Corporation is provided with regular and timely information on the overall financial performance of the College together with other information such as performance against funding targets, proposed capital expenditure, quality matters and personnel related matters such as health and safety and environmental issues.

The Corporation meets at least once each term.

The Corporation conducts its business through a number of committees. Each committee has terms of reference, which have been approved by the Corporation. These committees are finance and general purposes, curriculum and learning, remuneration, search and audit. Full minutes of all meetings, except those deemed to be confidential by the Corporation, are available on the College's website (jcc.ac.uk) or from the Clerk to the Corporation at:

The Clerk to the Corporation maintains a register of financial and personal interests of the governors. The register is available for inspection at the above address.

All governors are able to take independent professional advice in furtherance of their duties at the College's expense and have access to the Clerk to the Corporation, who is responsible to the Board for ensuring that all applicable procedures and regulations are complied with. The appointment, evaluation and removal of the Clerk are matters for the Corporation as a whole.

Formal agendas, papers and reports are supplied to the governors in a timely manner, prior to Board meetings. Briefings are also provided on an ad-hoc basis.

The Corporation has a strong and independent non-executive element and no individual or group dominates its decision making process. The Corporation considers that each of its non-executive members is independent of management and free from any business or other relationship which could materially interfere with the exercise of their independent judgement.

There is a clear division of responsibility in that the roles of the Chair of the Corporation and the Chief Accounting Officer of the College are separate.

## Appointments to the Corporation

Any new appointments to the Corporation are a matter for the consideration of the Corporation as a whole. The Corporation has a search committee comprising the Chair of the Corporation, the Principal, two other members of the Corporation and a co-opted member from the local community, which is responsible for the selection and nomination of any new member for the Corporation's consideration. The Corporation is responsible for ensuring that appropriate training is provided as required.

Members of the Corporation are appointed for a term of office not exceeding 4 years.

#### **Remuneration Committee**

The College's terms of reference indicate that the Remuneration Committee should comprise four members of the Corporation, excluding staff and student Governors. The Chair of this Committee is the Chair of the main Corporation. The members who served on this Committee throughout the year to 31 July 2020 are noted on page 16.

The Committee's responsibilities are to make recommendations to the Board on the remuneration and benefits of the Chief Accounting Officer and other senior post holders.

Details of the remuneration for the year ended 31 July 2020 are set out in note 7 to the Financial Statements.

#### **Audit Committee**

The College's terms of reference indicate that the Audit Committee should comprise of five members of the Corporation. The Chair of the Corporation, members of the F&GP Committee, Staff Governors and the Chief Accounting Officer are excluded from membership of the Audit Committee. The members who served on this Committee throughout the year to 31 July 2020 are noted on page 16. The Committee operates in accordance with written terms of reference approved by the Corporation.

The Audit Committee meets at least once per term and provides a forum for reporting by the College's internal, regularity and financial statement auditors, who have access to the Committee for independent discussion, without the presence of College management. The Committee also receives and considers reports from the main FE funding bodies as they affect the College's business.

The College's internal auditors review the system of internal control, risk management controls and governance processes in accordance with an agreed plan of input and report their findings to management and the Audit Committee.

Management is responsible for the implementation of agreed audit recommendations and internal audit undertakes periodic follow up reviews to ensure such recommendations have been implemented.

The Audit Committee also advises the Corporation on the appointment of internal, regularity and financial statement auditors and their remuneration for both audit and non-audit work as well as reporting annually to the Corporation.

# Finance & Resources Committee (formerly F&GP) Committee

The College's terms of reference indicate that the FRC Committee should comprise six members of the Corporation including the Chair of the Corporation and the Chief Accounting Officer. The members who served on this Committee throughout the year to 31 July 2020 are noted on page 16. The Committee operates in accordance with written terms of reference approved by the Corporation.

The FRC Committee meets at least once per term whose primary role is to advise the Main Board on matters of Finance, The principal terms of reference include making recommendations to the Corporation on the following matters:-

- Approval of Financial Statements;
- Approval of College annual and revised budgets and any financial forecasts required by Funding Bodies;
- Review of Management Accounts;

- Approve major capital expenditure projects and any associated borrowings;
- · Receive reports on any major contracts;
- · Approve, where appropriate, College Accommodation strategy;
- · Determining College investment and borrowing policies; and
- Monitor financial data for sub-contracting arrangements.

This and other Committees also review the College's proposed Strategic Plan and Self-Assessment Report.

#### **Internal Control**

Scope of responsibility

The Corporation is ultimately responsible for the College's system of internal control and for reviewing its effectiveness. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

The Corporation has delegated the day-to-day responsibility to the Principal, as Chief Accounting Officer, for maintaining a sound system of internal control that supports the achievement of the College's policies, aims and objectives, whilst safeguarding the public funds and assets for which he/she is personally responsible, in accordance with the responsibilities assigned to him in the Condition of Funding Agreement between Joseph Chamberlain Sixth Form College and the funding bodies. He is also responsible for reporting to the Corporation any material weaknesses or breakdowns in internal control.

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives; it can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an on-going process designed to identify and prioritise the risks to the achievement of College policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised and to manage them efficiently, effectively and economically. The system of internal control has been in place in Joseph Chamberlain Sixth Form College for the year ended 31 July 2020 and up to the date of approval of the annual report and accounts.

Capacity to handle risk

The Corporation has reviewed the key risks to which the College is exposed, together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The Corporation is of the view that there is a formal on-going process for identifying, evaluating and managing the College's significant risks that has been in place for the period ending 31 July 2020 and up to the date of approval of the annual report and accounts. This process is regularly reviewed by the Corporation.

The risk and control framework

The system of internal control is based on a framework of regular management information, administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting systems with an annual budget, which is reviewed and agreed by the Corporation
- regular reviews by the Corporation of periodic and annual financial reports, which indicate financial performance against forecasts
- setting targets to measure financial and other performance
- clearly defined capital investment control guidelines
- the adoption of formal project management disciplines, where appropriate.

### **Internal Control (continued)**

#### The risk and control framework (continued)

Joseph Chamberlain Sixth Form College has an internal audit service, which operates in accordance with the requirements of the ESFA Post 16 Audit Code of Practice. The work of the internal audit service is informed by

the College's analysis of the risks to which the College is exposed. The internal audit service provides the Corporation with reports on the agreed areas of College activity.

The analysis of risk and the internal audit reports are endorsed by the Corporation on the recommendation of the Audit Committee.

Review of effectiveness

As Chief Accounting Officer, the Principal has responsibility for reviewing the effectiveness of the system of internal control. They have reviewed the effectiveness of the system of internal control is informed by:

- the work of the internal auditors
- the work of the executive managers within the College who have responsibility for the development and maintenance of the internal control framework
- comments made by the College's financial statements auditors and the reporting accountants for regularity assurance in their management letters and other reports.

The Chief Accounting Officers in post during the year have been advised on the implications of the result of their review of the effectiveness of the system of internal control by the Audit Committee, which oversees the work of the internal auditor and other sources of assurance, and a plan to address weaknesses and ensure continuous improvement of the system is in place.

The Senior Leadership Team receives reports setting out key performance and risk indicators and considers possible issues brought to their attention by early warning mechanisms which are embedded within the departments and reinforced by risk awareness training. The Senior Leadership Team and the Audit Committee also receive regular reports from internal audit, which include recommendations for improvement. The Audit Committee's role in this area is confined to a high level review of the arrangements for internal control. The Corporation's agenda includes a regular item for consideration of risk and control and receives reports thereon from the Senior Leadership Team and the Audit Committee. The emphasis is on obtaining the relevant degree of assurance and not merely reporting by exception. At its meeting on 15 December 2020, the Corporation received a report from the Audit Committee on the annual activities and assessments carried out in 2019/20. The Audit Committee report and assurance will be based on the documentation presented to them by the Senior Leadership Team and internal auditors and taking account of events since 31 July 2020.

Based on the advice of the Audit Committee the Corporation is of the opinion that the College has an adequate and effective framework for governance, risk management and control, and has fulfilled its statutory responsibility for "the effective and efficient use of resources, the solvency of the College and the safeguarding of their assets".

# **Going Concern**

The College's financial health has been retained at a "Outstanding" rating for 2019/20 with underlying performance at £1,056,000 surplus which is better than in year forecasts despite the impact of COVID19. Careful management and monitoring of budgets and a remote delivery model to continue learning alongside government and ESFA related support mechanisms have contributed to the successful financial outcome. The College also incurred c£40,000 of COVID19 related expenditure ensure the campus was COVID19 secure prior to reopening.

The College budget for 2020/21 has been approved at a surplus of £970,000 in July 2020 which will allow for the retention of a "Outstanding" health rating. The supporting income and expenditure streams have been heavily risked to take in to account the ongoing impact of COVID19 and also the challenging financial climate. Expenditure budgets also include for the relevant amounts to secure the campus continues to be COVID19 secure and is adequately cleaned, equipped and socially distanced to provide a safe environment to all. Associated cash

### Going Concern (continued)

flow forecasts supporting the budgets indicate the College will retain sufficient working capital to traverse all low points in 2020/21 with sufficient headroom without recourse to addition al facilities.

After making appropriate enquiries including consideration of the financial forecast plan, the budget for 2020/21, short and long term cash flow forecasts and current banking facilities, the Corporation considers that the College has adequate resources to continue in operational existence for the foreseeable future. For this reason, it continues to adopt the going concern basis in preparing the financial statements.

The College's financial health was rated as "Outstanding" by the ESFA for 2018/19 based on the submission of the signed financial statements. The financial health remains "Outstanding" based on the College's self-assessment of the financial statements for 2019/20. Financial plans and budgets for 2020/21 have been set to retain the "Outstanding" health rating.

#### Notes to the Accounts

1. Statement of accounting policies and estimation techniques

#### **General Information**

Joseph Chamberlain Sixth Form College ("the College") is a corporation established under the Further & Higher Education Act 1992 as an English sixth form college of further education. The registered office address of the Company is 1 Belgrave Road, Highgate, Birmingham, B12 9FF. The nature of the College's operations is set out in the Members' Report.

Statement of accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements.

Basis of preparation

These Financial Statements have been prepared in accordance with the Statement of Recommended Practice: Accounting for Further and Higher Education 2015 (the 2015 FE HE SORP), the College Accounts Direction for 2019/20 and in accordance with Financial Reporting Standard 102 – "The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland" (FRS102).

The College is a public benefit entity and has therefore applied the relevant public benefit requirements of FRS 102.

The College has taken advantage of the exemptions provided in FRS 102 1.12 and the 2015 FE HE SORP 3.3, and has not included a separate statement of its own cash flows. These cash flows are included within the Consolidated Statement of Cash Flows, and the College Balance Sheet discloses cash at both the current and preceding reporting dates.

The preparation of Financial Statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the College's accounting policies.

Monetary amounts in these Financial Statements are rounded to the nearest £1,000 except where stated.

Basis of accounting

The Financial Statements are prepared under the historical cost convention.

Basis of consolidation

The consolidated Financial Statements include the College and its subsidiary undertaking, Joseph Chamberlain Trading Limited and its subsidiary public interest company The College for International Citizenship CIC both of which are controlled by the Group.

Control is achieved where the Group has the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. Intra-group transactions, profits and balances are eliminated fully on consolidation. All Financial Statements are made up to 31 July 2020.

Going Concern

The activities of the College, together with the factors likely to affect its future development and performance are set out in the Members' Report. The financial position of the College, its cash flow, liquidity and borrowings are presented in the Financial Statements and accompanying Notes.

The College does not have any bank borrowings as the previous Loan was fully repaid in December 2019.

## Notes to the Accounts (continued)

### 1. Statement of accounting policies and estimation techniques (continued)

#### Going Concern (continued)

The financial impact of COVID has had no material impact on the financial position of the College due to the ongoing guarantee on 16-18 funding for 2020/21 and 2021/22 from the ESFA. There is some uncertainty over the adult funding position but the College would be able to partially mitigate any funding reductions. Cash flow up to 31 July 2022 remains positive and the College has significant cash reserves at its disposal to overcome the ongoing uncertainty over COVID as the outbreak unfolds.

Accordingly, the College has a reasonable expectation that it has adequate resources to continue in operational existence for the foreseeable future, and for this reason will continue to adopt the going concern basis in the preparation of its Financial Statements.

#### Recognition of income

Government revenue grants and other grants and are accounted for under the accrual model as permitted by FRS 102 and are recognised where a reliable estimate of the fair value of the asset received or receivable can be made on a systematic basis over the periods in which the related costs for which the grant compensates are recognised. Funding body recurrent grants are measured in line with best estimates for the period of what is receivable and depend on the particular income stream involved. Any under achievement for the Adult Education Budget is adjusted for and reflected in the level of recurrent grant recognised in the Statement of Comprehensive Income. The final grant income is normally determined with the conclusion of the year end reconciliation process with the funding body following the year end, and the results of any funding audits. 16-18 learner-responsive funding is not normally subject to reconciliation and is therefore not subject to contract adjustments, and is recognised when receivable.

Grants from non-government sources are recognised in income when the College is entitled to the income and performance related conditions have been met. Income received in advance of performance related conditions being met is recognised as deferred income within creditors on the Balance Sheet and released to income as the conditions are met.

Government capital grants are capitalised, held as deferred income and recognised in income over the expected useful life of the asset, under the accrual method as permitted by FRS 102. Other capital grants are recognised in income when the College is entitled to the funds subject to any performance related conditions being met.

The recurrent grant from the Office for Students (OfS) represents the funding allocation attributable to the current financial year and is recognised when received or receivable.

Income from tuition fees is stated gross of any expenditure which is not a discount and is recognised in the period for which it is earned.

All income from short-term deposits is credited to the Statement of Comprehensive Income in the period in which it is earned on a receivable basis.

#### Accounting for post-employment benefits

Post-employment benefits to employees of the College are principally provided by the Teachers' Pension Scheme (TPS) and the Local Government Pension Scheme (LGPS). These are multi-employer defined benefit plans, which are externally funded and contracted out of the State Second Pension

The TPS is an unfunded scheme. Contributions to the TPS are calculated so as to spread the cost of pensions over employees' working lives with the College in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of valuations using a projected unit method. The TPS is a multiemployer scheme and the College is unable to identify its share of the underlying assets and liabilities of

the scheme on a consistent and reasonable basis. The TPS is therefore treated as a defined contribution plan and the contributions recognised as an expense in the Statement of Comprehensive Income in the periods during which services are rendered by employees. Differences between contributions payable in the year and contributions paid are shown as either accruals or prepayments.

The LGPS is a funded scheme and the assets of the Scheme are held separately. The assets of the LGPS are measured using closing fair values. LGPS liabilities are measured using the projected unit credit method and discounted at the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the Statement of Comprehensive Income and included within finance costs. This comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other comprehensive income.

Remeasurements comprising actuarial gains and losses and the return on scheme assets (excluding amounts included in net interest) are recognised immediately in other comprehensive income.

Short term Employment benefits

Short term employment benefits such as salaries and compensated absences (holiday pay) are recognised as an expense in the year in which the employees render service to the College. Any unused benefits are accrued and measured as the additional amount the College expects to pay as a result of the unused entitlement.

**Enhanced pensions** 

The actual cost of any enhanced on-going pension to a former member of staff is paid by the College annually. An estimate of the expected future cost of any enhancement to the on-going pension of a former member of staff is charged in full to comprehensive income in the year that the member of staff retires. In subsequent years, a charge is made to provisions in the Balance Sheet using the enhanced pension spread-sheet provided by the funding bodies.

Non-current Assets - Tangible fixed assets

Tangible fixed assets are stated at cost less accumulated depreciation and accumulated impairment losses.

Land and buildings

Freehold buildings are depreciated on a straight line basis over their expected useful lives as follows:

Main College Campus – 50 years

Freehold land is not depreciated.

The College has a policy of depreciating major adaptations to buildings over the period of their useful economic life of between 20 and 50 years.

Where land and buildings are acquired with the aid of specific Government grants, they are capitalised and depreciated as above. The related grants are credited to a deferred income account within creditors, and are released to the Statement of Comprehensive Income over the expected useful economic life of the

related asset on a systematic basis consistent with the depreciation policy. The deferred income is allocated between creditors due within one year and those due after more than one year.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying amount of any fixed asset may not be recoverable.

#### Assets under Construction

Assets under construction are accounted for at cost, based on the value of architects' certificates and other direct costs, incurred to 31 July. They are not depreciated until they are brought into use.

#### Subsequent expenditure on existing fixed assets

Where significant expenditure is incurred on tangible fixed assets after initial purchase it is charged to the Statement of Comprehensive Income account in the period it is incurred, unless it increases the future benefits to the College, in which case it is capitalised and depreciated on the relevant basis.

#### Equipment

Equipment costing less than £1,000 per individual item is recognised as expenditure in the period of acquisition, unless the individual item is part of a major replacement programme, in which case such items may be capitalised. All other equipment is capitalised at cost.

Capitalised equipment is depreciated on a straight-line basis over its remaining useful economic life as follows:

•	Plant and equipment	5-15 years
•	motor vehicles	5 years
•	computer equipment	3-5 years
•	furniture, fixtures and fittings	5-10 years

Where equipment is acquired with the aid of specific Government grants, they are capitalised and depreciated as above. The related grants are credited to a deferred income account within creditors, and are released to the Statement of Comprehensive Income over the expected useful economic life of the related asset on a systematic basis consistent with the depreciation policy. The deferred income is allocated between creditors due within one year and those due after more than one year.

#### Leased assets

Costs in respect of operating leases are charged on a straight-line basis over the lease term.

Leasing agreements which transfer to the College substantially all the benefits and risks of ownership of an asset are treated as finance leases. As at 31 July 2020 the College did not have any finance lease agreements.

#### Investments

#### Investments in subsidiaries

Investments in subsidiaries are accounted for at cost less impairment in the individual Financial Statements.

## 1. Statement of accounting policies and estimation techniques (continued)

Cash and cash equivalents

Cash includes cash in hand, deposits repayable on demand and overdrafts. Deposits are repayable on demand if they are in practice available within 24 hours without penalty.

Cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash with insignificant risk of change in value.

#### Financial instruments

The Group has chosen to adopt Sections 11 and 12 of FRS102 in full in respect of financial instruments.

Financial assets and liabilities

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument. Financial liabilities and equity are classified according to the substance of the financial instrument's contractual obligations, rather than the financial instrument's legal form. All financial assets and liabilities are initially measured at transaction price (including transaction costs), except for those financial assets measured at fair value through the profit or loss, which are initially measured at fair value (which is normally the transaction price excluding transaction costs), unless arrangement constitutes a financing transaction. A financial asset or financial liability that is payable or receivable in one year is measured at the undiscounted amount expected to be received or paid net of impairment, unless it is a financing transaction. If an arrangement constitutes a financing transaction, the financial asset or financial liability is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Financial assets and financial liabilities are offset only when there is a current legally enforceable right to set off the recognised amounts and the intention to either settle on a net basis, or to realise the asset and settle the liability simultaneously.

Derecognition of financial assets and liabilities

A financial asset is derecognised only when the contractual rights to cash-flows expire or are settled, or substantially all the risks and rewards of ownership are transferred to another party, or if some significant risk and rewards of ownership are retained but control of the asset has transferred to another party that is able to sell the asset in its entirety to an unrelated third party. A financial liability (or part thereof) is derecognised when the obligation specified in the contract is discharged, cancelled or expires.

Foreign currency translation

Transactions denominated in foreign currencies are recorded using the rate of exchange ruling at the date of the transaction.

#### Taxation

The College is considered to pass the tests set out in Paragraph 1 Schedule 6 Finance Act 2010 and therefore it meets the definition of a charitable company for UK Corporation Tax purposes. Accordingly, the College is potentially exempt from taxation in respect of income or capital gains received within categories covered by sections 478-488 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

The College is partially exempt in respect of Value Added Tax, so that it can only recover a minor element of the VAT charged on its inputs. Irrecoverable VAT on inputs is included in the costs of such inputs and added to the cost of tangible fixed assets as appropriate, where the inputs themselves are tangible fixed assets by nature.

The College's subsidiary companies are subject to Corporation Tax and VAT in the same way as any commercial organisation.

1. Statement of accounting policies and estimation techniques (continued).

Provisions and contingent liabilities

Provisions are recognised when the College has a present legal or constructive obligation as a result of a past event, it is probable that a transfer of economic benefit will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

Where the effect of the time value of money is material, the amount expected to be required to settle the obligation is recognised at present value using a pre-tax discount rate that reflects the rates specific to the liability. The unwinding of the discount is recognised as a finance cost in the Statement of Comprehensive Income in the period it arises.

A contingent liability arises from a past event that gives the College a possible obligation whose existence will only be confirmed by the occurrence or otherwise of uncertain future events not wholly within the control of the College. Contingent liabilities also arise in circumstances where a provision would otherwise be made but either it is not probable that an outflow of resources will be required or the amount of the obligation cannot be measured reliably.

Contingent liabilities are not recognised in the Balance Sheet but are disclosed in the notes to the Financial Statements.

Agency arrangements

The College acts as an agent in the collection and payment of bursary support funds from the funding bodies. Related payments received from the funding bodies and subsequent disbursements to students are excluded from the Statement of Comprehensive Income of the College where the College does not have control of the economic benefit related to the transaction.

Judgements in applying accounting policies and key sources of estimation uncertainty In preparing these financial statements, management have made the following judgements:

Determine whether there are indicators of impairment of the group's tangible assets. Factors taken into consideration in reaching such a decision include the economic viability and expected future financial performance of the asset and where it is a component of a larger cash-generating unit, the viability and expected future performance of that unit.

#### Other key sources of estimation uncertainty

Tangible fixed assets

Tangible fixed assets are depreciated over their useful lives taking into account residual values, where appropriate. The actual lives of the assets and residual values are assessed annually and may vary depending on a number of factors. In re-assessing asset lives, factors such as technological innovation and maintenance programmes are taken into account. Residual value assessments consider issues such as future market conditions, the remaining life of the asset and projected disposal values.

• Local Government Pension Scheme

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost (income) for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 24, will impact the carrying amount of the pension liability. Furthermore, a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 July 2020. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Contributions amounting to £27,189 (2019: £26,575) and £120,466 (2019: £81,342) were payable to the LGPS and TPS schemes respectively at 31 July 2020 and are included within creditors.

The College has agreed with the LGPS to contribute £14,000 per annum in the next three years to contribute towards the scheme deficit. The position will be reviewed at the next triennial valuation.

#### Teachers' Pension Scheme

The Teachers' Pensions Scheme ("TPS") is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pensions Regulations 2010, and, from 1 April 2014, by the Teachers' Pension Scheme Regulations 2014. These regulations apply to teachers in schools and other educational establishments, including academies, in England and Wales that are maintained by local authorities. In addition, teachers in many independent and voluntary-aided schools and teachers and lecturers in some establishments of further and higher education may be eligible for membership. Membership is automatic for full-time teachers and lecturers and, from 1 January 2007, automatic too for teachers in part-time employment following appointment or a change of contract. Teachers and lecturers are able to opt out of the TPS.

The TPS is an unfunded scheme and members contribute on a "pay as you go" basis – these contributions, along with those made by employers, are credited to the Exchequer under arrangements governed by the above Act. Retirement and other pension benefits are paid by public funds provided by Parliament

#### Valuation of the Teachers' Pensions Scheme

Not less than every four years the Government Actuary ("GA"), using normal actuarial principles, conducts a formal actuarial review of the TPS. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors.

The latest actuarial valuation was carried out at 31 March 2016 and in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 except it has been prepared following the Government decision to pause the operation of the control mechanisms at the time when legal challenges were still pending. The valuation report was published by the Department for Education in April 2019. The valuation reported total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218 billion, and notional assets (estimated future contributions together with notional investments held at the valuation date) of £196 billion giving a notional past service deficit of £22 billion. The key results of the valuation and subsequent consultations are:

- Total scheme liabilities of £218 billion;
- Value of notional assets of £196 billion;
- Notional past service deficit of £22 billion;
- Assumed real rate of return is 3% in excess of prices and 2% in excess of earnings;
- Rate of real earnings growth is assumed to be 2.75%;
- Assumed nominal rate of return is 5.06%;

As a result of the valuation, new employer contribution rates were set at 23.68% of pensionable pay from September 2019 onwards (compared to 16.48% during 2018/19. The Department for Education has agreed to pay a teacher pension employer contribution grant to cover the additional costs until 31 March 2021. The next valuation result is due to be implemented from 1April 2023.

The pension costs paid to TPS in the year amounted to £973,000 (2019: £617,000).

Under the definitions set out in FRS 102 (28.11), the TPS is a multi-employer pension plan. The College is unable to identify its share of the underlying assets and liabilities of the plan.

Accordingly, the College has taken advantage of the exemption in FRS 102 and has accounted for its contributions to the scheme as if it were a defined-contribution plan. The College has set out above the information available on the plan and the implications for the College in terms of the anticipated contribution rates.

#### **Local Government Pension Scheme**

The LGPS is a funded defined-benefit scheme, with the assets held in separate funds administered by West Midlands Metropolitan Authorities Pension Fund. The total contributions made for the year ended 31 July 2020 was £341,000 of which employer's contributions totalled £253,000 and employees' contributions totalled £98,000. The agreed contribution rate from 1 April 2017 was 17% for employers and range from 5.5% to 12.5%, for employees depending on salary. The contributions from 1 April 2020 were 17.9% for employer and between 5.5% and 12.5% for employees depending on salary.

As a result of the High Court's recent Lloyds ruling on the equalisation of Guaranteed Minimum Pension (GMP) between genders, a number of pension schemes have made adjustments to accounting disclosures to reflect the effect this ruling has on the value of pension liabilities. It is the opinion of the scheme actuary that HM Treasury have confirmed that the judgement "does not impact on the current method used to achieve equalisation and indexation in public service pension schemes".

On 22 January 2018, the Government published the outcome to its *indexation and equalisation of GMP in public service pension schemes* consultation concluding that the requirement for public service pension schemes to fully protect the GMP element of individuals' public service pension would be extended to those individuals reaching State Pension Age (SPA) before 6 April 2021. HM Treasury published a Ministerial Direction on 4 December 2018 to implement this outcome, with effect from 2 April 2016.

The actuaries valuation assumption for GMP is that the Fund will pay limited increases for members that have reached SPA by 6 April 2016, with the Government providing the remainder of the inflationary increase. For members that reach SPA after this date, the actuaries have assumed that the Fund will be required to pay the entire inflationary increase. Therefore, the actuaries do not believe they need to make any adjustments to the value placed on liabilities as a result of the above outcome.

#### Conclusion

In line with this framework, our work has specifically not considered income received from the main funding grants generated through the Individualised Learner Record (ILR) returns, for which the ESFA has other assurance arrangements in place.

We are independent of the Joseph Chamberlain Sixth Form College in accordance with the ethical requirements that are applicable to this engagement and we have fulfilled our ethical requirements in accordance with these requirements. We believe the assurance evidence we have obtained is sufficient to provide a basis for our conclusion

Responsibilities of Corporation of Joseph Chamberlain Sixth Form College for regularity
The Corporation of Joseph Chamberlain Sixth Form College is responsible, under the grant funding agreements and contracts with the ESFA and the requirements of the Further & Higher Education Act 1992, subsequent legislation and related regulations and guidance, for ensuring that expenditure disbursed and income received is applied for the purposes intended by Parliament and the financial transactions conform to the authorities which govern them. The corporation of Joseph Chamberlain Sixth Form College is also responsible for preparing the Governing Body's Statement of Regularity, Propriety and Compliance.
